- I. **Executive Session** The Charitable Trust, NESCO and the IRS were discussed during this portion of the meeting.

II. Welcome

III. DPW RebuildIndy - Storm Water Presentation by Michael Massone

- Department of Public Works maintains and oversees the storm water systems
- City County Council and Department of Public Works approves.
- Storm water user fees are included in property taxes.
- The United States Clean Water Act requires water quality and storm water quantity limits
- Current problems flooded roads, aging storm water systems
- 300,000 customers served by Marion County storm water program
- Aging infrastructure i.e. pipes, drains that needs addressed. When replacing plan is to put in 75 year life infrastructure components.

- Proposed changes to fees reduce to \$1.10 per 1000 square feet of impervious space. Revise billing of residential properties to reflect actual amount of impervious space. Estimated that 20% of residential properties will remain about the same or less.
- 15 million a year proposed in operating costs to start being more preventive and less reactive.
- Monthly storm water rate will remain less than surrounding counties.
- For complaints of flooding call Citizens Energy Group 317-924-3311
- Property owners are asked to keep storm drains near/on property cleared.

- Zach Adamson Provided another perspective on waste water. Zach stated this is a solid proposal. A bill has been postponed at the City Council due to a concern that should we allow this rate increase, this Waste Water entity would be put on the auction block by the city to resale because it has become more financially desirable.
