Welcome & Introduction

• The meeting opened at 6:30 pm. Kelly Wensing invited those present to introduce themselves.

Public Comments:

- Earth Charter meeting Thurs. Sept 25 at 7 pm at the Atheneum regarding the relationship between green (ecological) and neighborhoods of color (race) and how they relate to the consumption of energy.

Board Business:

- Approval of Minutes Stephen Ball asked if the group had any changes to the July 2014 board minutes.

- Treasurers Report –Matt Belsaas reported on the Feast of Lanterns budget. (See baseline totals under FOL report under Old Business)
- Presidents Report Kelly Wensing Discussed the lending of strings of FOL lights to the Indy Parks Indy Farms on Shadeland Ave this Saturday, Sept 27 for their fundraiser. We would like to help but are concerned there is not enough time.

New Business/Call to Action:

• Hoosier Rails to Trails Council – Presented by Mario Vian – There are plans for a national cross country bicycle routes. Route 35 is the section proposed thru Marion County, and it needs to be approved. Hoosier Rails to Trails advocates turning railway tracks into bicycle trails. Mario Vian asked for NECO's endorsement for one of two possible interstate bicycle routes. The route Mario Vian proposes goes through NESCO neighborhoods and may provide revenue from bikers using the route. The other route is more direct and takes less time, but bypasses more of the Near Eastside. A letter of support is needed by Dec. 1. A letter of support will be presented for approval at the next NESCO Board meeting.

• Promise Zones – Megan Fetter presented the initiative. The federal government is offering a program for 10 federally designated selected communities through HUD. The "Promise Zone" has the potential to leverage federal funds for improving the quality of life in the Near Eastside. Though not providing funding itself, the HUD Promise Zone designation gives clout to apply for grants from various agencies of the federal government. Applications for the Promise Zone are assessed on a point system based on economic need and thoroughness of planning. Only one application in the city can have the support of the Indianapolis government. Discussion centered around whether to include all NESCO neighborhoods or those with the highest unemployment and least income. There are 60 days to get application done which is due Nov. 1. The Promise Zone initiative will be presented at the Oct 1 Summit Meeting at East 10th St. Methodist.
