Attendee Introductions and Neighborhood Updates: Meeting attendees introduced themselves.

<u>Prior meeting minutes</u>: Review February 28, 2017 meeting minutes. Motion by Chris Staab: Accept meeting minutes. 2<sup>nd</sup>: Pat Paff. Vote to approve with 1 abstention.

<u>Treasurer's report</u>: [Emailed report from Rebecca Seifert] Checking 03/26/2017: \$12,193.96 Charitable Trust 02/28/2017: \$14,701.01 2017 NESCO Congress silent auction: Sales: \$1,146.80 Reimbursed expenses: \$75.93 Net proceeds: \$1,070.87

Charitable Trust – until the Trust is legally dissolved, the accounts need to be kept separate. Ashlie Keaton is working through this process.

Going forward – NESCO's expenses are relatively minimal:

- Annually, we pay two insurance premiums one is for Directors and Officer's insurance (approximately \$778.00) you must have. This renews in July our insurance agent is MJ Schuetz.
- NESCO also has a Commercial Policy (approximately \$650.00) that is due in February.
- Those are the bulk of NESCO operating expenses.

Other notes -

- NESCO IRS 990 will be filed in May 2017
- Annually the business entity report needs to be filed in August every year with the secretary of state go to the secretary of state's web site- there is a filing fee it is minimal. [Note: August 29, 2016: Last entity report for NESCO (see <u>bsd.sos.in.gov/publicbusinesssearch</u>)

Crime Reduction and Code Enforcement Committee: Chris Staab:

Land Use Committee: David Hittle sent it out report which was forwarded to everyone on email list. The last (20<sup>th</sup> year) April Show will be Friday, April 28, 2017 700p at 322 North Arsenal Avenue.

<u>I am Ubuntu/Indy East Diversity and Inclusion</u>: Discussions on funding persons to attend 2017 Neighborhoods, USA (NUSA) conference in Omaha in May 2017. Funding request is \$733.00/person includes expenses such as airfare, hotels, and conference fees.

The Near Eastside ReEntry Expo brought together neighbors, service providers, business owners, city representatives, & community leaders from Indianapolis' eastside to celebrate neighbors who have returned from being incarcerated.

- April 23, 2016: Near East ReEntry Expo held at All That Jazz Café and Blues (2127 East 10<sup>th</sup> Street)
- September 27, 2016: Won Collaborative Spirit Award by Indianapolis Neighborhood Resource Center which made group eligible to compete at 2017 NUSA conference.
- March 4, 2017: Won Honorable mention award at NeighorPower (Neighbor Power created a new category for future conferences for similar projects)

Motion by Satchuel Cole: Move to fund two people from I am Ubuntu/Indy East Diversity and Inclusion attend the 2017 NUSA conference in May 2017 for \$1,466.00. 2<sup>nd</sup>: Jen Eamon.

The group from I am Ubuntu/Indy East Diversity and Inclusion provided information on conference workshops that will attend and bring back presentations for near eastside organizations. The group will be presenting their event and competing against other neighborhood projects from throughout U.S. Other near eastside organizations are assisting in supporting group (John H. Boner Community, Indianapolis Neighborhood Resource Center, Rivoli Park Neighborhood, Local Initiatives Support Corporation Community Hospital). Next ReEntry event: Friday, June 16, 2017 and Saturday, June 17, 2017 (details forthcoming).

organizations that NESCO started and/or has boots on the ground. Organizations discussed for potential financial support: John H. Boner Harvest Celebration, Feast of Lanterns (\$5,000.00 title sponsorship).

Pi Day: Final wrap-up report with be provided during April 2017 meeting.

<u>Black Lives Matter (BLM) Parnership</u>: Satchuel Cole: Every month the group assembles Operation Care Kits at Englewood Christian Church / Commonwealth Gym (23 North Rural Street) that are distributed to homeless. Items include: socks, shampoo, soap, razor, toothpaste, food, etc. BLM needs a fiscal agent. BLM is currently not a 501c3 and donors aren't able to deduct donations.

Motion by Valerie Davis: Move to create three month fiscal agent partnership during April, May, June 2017 between NESCO and Black Lives Matter. 2<sup>nd</sup>: Kevin Green.

Discussions: Need to create formal written agreement between NESCO and BLM. Marsha Burkhardt is volunteer treasurer and will workload be excessive? Try out partnership for three month period and review after that time period. Bus passes are big item that is frequently donated.

Vote to approve with 1 no vote.
