<u>Pat Paff:</u> Rivoli Park Neighborhood having neighborhood cleanup Saturday, October 14, 2017: Lasalle and Dearborn streets <u>Ashley Ellis</u>: Duvall Residential Facility will be helping Neighborhoods with cleanups: October 7 (Grace Tuxedo) and October 14 (Rivoli Park) <u>Stephen Ball</u>: House Life Project has event Saturday, August 26, 2017 along with Feast of Lanterns on same day. <u>Mark Frisbie</u>: Grace Tuxedo is getting organized – will have VP and Treasurer election and working on Bylaws. Working with Tuxedo Park Baptist Church on park. Partnering with Hollywood Place and Bosart Brown for same day/time meetings. <u>IREF Task Force</u>: Satchuel Cole: During the Near Eastside Neighborhood Summit held on July 27, 2017 a motion for creating a IREF site task force was approved. Valerie and Stephen are interested in being part of group. Will provide updates from the IREF site task force for the next Summit on Thursday, October 26, 2017. Quality of Life Plan will be getting updated.

<u>Black Lives Matter</u>: Satchuel Cole: NESCO serves as fiscal sponsorship for Operation Care Kit project. BLM hasn't received any funds yet so haven't needed to utilize the relationship. Last kit assembly date was August 19, 2017.

In December 2016 BLM held Santa Claus event at the building that now houses NEAR. Activities included cookies, photos, Santa Claus letters and providing Christmas tree to families. Discuss NESCO serving as fiscal sponsorship for event but since no quorum at tonight's meeting Jim suggested that Rivoli Park Neighborhood could provide that for this event and would add to the organization September meeting agenda. Having 501c3 relationship allows donations of cookies, hot chocolate for the event.
