Treasurer's Report: General Account, as of September 22: \$4917.65 (\$2.30 interest)

#### **Committee Reports: 10 minutes**

- <u>Land Use Committee-</u> David Price acting Chair; September 19th Meeting regarding 2024-MOD-015 at 3500 E 20th St
  - The 4545 E Michigan St Petitioner for 2024-ZON-056 & 2024-VAR-009 was heard by the Hearing Examiner on August 29th and denied, Metropolitan Development Commission also denied 2024-ZON 056 on September 18th. The Petitioner has sent a letter to NESCO and Jesse Brown for an appeal
  - o Also the hearing for the Bonner Center Parking is coming up. Hearing was postponed
- <u>NESCO Liquor Committee</u> Jim Bowden; Chair No September Meeting; October Liquor Board cases were attached to agenda. License for Tic Toc is being transferred due to change in ownership. Kankan is renewing their license. Sam's Pie has applied for a liquor license
- Crime Reduction Code Enforcement Chris Staab; Next meeting on October 7<sup>th</sup>
- Fund Raising Committee Jim Bowden; Chair. No September Meeting
- <u>Grant Committee- Chris Staab</u> No September Meeting; INRC Grant financial completed. INRC refund submitted

### New / Continuing Business: 30-45 minutes

- Updates from Andrew Carson's Office
  - o Reminders: Job Fair is every August, Youth Fair is always held in March
  - o In Martindale-Brightway, there is a leaking cast iron pipe and Citizens Energy which will be addressed
  - There is a \$15million grant to deploy electric EV charging stations in Indy to be implemented. The project is geared to equitable placement.
  - Energy Assistance Program Applications opened at Bonner on Oct 1, 2024; assistance begins in November.
  - Medicare sign up begins soon (Oct 15 7Nov). Note: do the Inflation Reduction Act, there is \$0 out of pocket costs for vaccines under Part D. Insulin Copay costs capped at \$35.00.
    - In 2025, a monthly prescription Payment Program will begin.
- MCANA September report the presenter at the 21Sep2024 meeting was from DPW on Sustainability. Ongoing discussion on the use of leaf blowers in regard to pollution and no zone days. Billboard Ordinance Proposal: it is going forward to the Metropolitan Development Commission to expand the billboard signage from 40' to 60'. If passed, the proposal will then go to the City Council for a vote.
  - Within Nesco there are 26+ billboards.
- **Feast of Lanterns Foundation**: Action for Nesco: to send a letter to the organizer of FoL Martha Latta, as well as the volunteers from NESCO that assisted that day.
- Emerson Height Fiscal agent discussion
  - Be the fiscal agent for the neighborhood to help ECHO, by setting up a PayPal account. This will require a vote by the ex-directors. Neighborhood is still researching the legalities. Nesco has offered to help in any way. Vote was tabled until we have we have a quorum from the Executive board at the next NESCO meeting.
- Women's Prison Land Swap State has agreed to transfer the property to the City of Indianapolis through an equitable exchange of land. The State will receive a portion of Sherman Park, and the Animal Control

acreage once their location is moved. The land swap won't occur until November, and the Animal Control property will not be available until late 2026.

- o Note: The prison is located in Willard Park, and Sherman Park is within Rivoli.
  - Willard will be hosting a celebration on the decision of the land swap, and to also celebrate the 151<sup>st</sup> anniversary of the neighborhood, date TBD.
- **KIB:** AAB Captain increased August 2023-2024 by 90!
- Mayors Advocate <u>rosemary.stockdale@indy.gov</u> 317-833-4938.
  - Rosie Stockade is our substitute Mayor's Advocate we have a permanent replacement assigned.
    Proposal 314 ordinance was offered by the City Council to reduce the racing events (spinners) around the city. Ordinance written by IMPD.
    - Reach out to your Councilman if you have questions.
  - o **Indy Parks:** SafeParksIndy.org is being set up where people are living in their cars. Hygiene stations will be provided. Exclusions would include those with DV charges or open warrants and violent crimes convictions.
- Indy Housing Community Authority: is working to remove the Lead paint ect at 440 N. Oxford. ICHCD can do an analysis of your house if requested.
